APPLICATION OF TARIFF

A. GENERAL

This tariff applies to local exchange telephone services furnished by Frontier Communications of Virginia, Inc. The exchanges and zones to which the regulations and rates contained herein apply are as specified on maps filed with the State Corporation Commission of Virginia. The regulations and rates contained herein are in addition to the applicable regulations and rates specified in other tariffs of the Telephone Company.

B. REGULATIONS

1. Local Exchange Service is provided only on an intraLATA basis, except for established local service areas in effect on December 31, 1983, which cross Local Access and Transport Area (LATA) boundaries.

2. Explanation of Terms

Monthly Usage Options

Monthly usage options provide customers with options for a type of local calling privilege other than being charged only on a per-call basis.

3. Application of Local Exchange Service Rates

a. Business and Residence

The determination as to whether customer service is furnished at business or residence rates is based on the location and character of use, made of the service. The type of Directory Listing may, in some cases, also serve as a satisfactory basis for determining whether business or residence rates apply.

Business Rates

Service is classified and charged for as business service where the use is primarily or substantially of a business, professional, institutional or occupational nature, or where a business Directory Listing is furnished, except as provided in the following paragraph.

Residence Rates

Service is classified and charged for as residence service where the primary use of the service is of a domestic nature, except that service may be furnished at residence rates in a clergyman's study located in a church. Included in this classification is service subscribed to by a nonprofit association of owners of residential condominiums for use with customer-provided door answering equipment.

3. Application of Local Exchange Service Rates (Cont'd)

b. Trunks

Private branch exchange (PBX) trunk rates apply for local exchange lines connecting in PBX common equipment, in multi-function systems where the lines are used as pooled facilities - dial or button access.

c. Touch-tone calling is included in Local Exchange Service.

4. Local Exchange Service rates provide service up to and including the network interface. The following Channel Services may be used with Local Exchange Service.

a. Foreign Exchange Service is exchange service furnished from one exchange to a location in another exchange by the use of Series 2000, type 2006A, Channels.

(1) Foreign Exchange Service is provided in accordance with such methods as are best suited to meet plant and operating requirements of the Telephone Company.

(2) Foreign Exchange Service is available only between exchanges located in the same LATA except as modified by the U. S. District Court for the District of Columbia in Civil Action No. 82-0192, dated December 7, 1983.

(3) Foreign Exchange Service will be provided to new customers only in connection with individual lines and PBX trunks.

(4) Where the normal and foreign exchanges are not contiguous, a customer to Foreign Exchange Service is required to subscribe also to some class of exchange service regularly furnished in the exchange in which the customer's premises is located.

(5) The rates and charges applicable to Foreign Exchange Service exchange lines and trunks are the rates and charges for the class of service furnished, applicable within the foreign exchange.

(6) The long distance and local message charges and the extent of local service applicable, are the same as apply to other Local Exchange Services provided from the same foreign exchange.

(7) The rates and charges for all other items of service and equipment are the rates and charges applicable in the area in which the customer's network interface is located.

a. (Cont'd)

(8) The rates specified for foreign exchange mileage for a Series 2000, type 2006A, Channel in this Company's Channel Services Tariff, Section 3, contemplate service over only those lines located in the same building with the foreign exchange main service.

b. Foreign Zone Service is exchange service furnished from one zone to a location in another zone in the same multi-zone exchange by the use of Series 2000, type 2006B, Channels.

(1) Foreign Zone Service is not in accord with the general plan of furnishing telephone service and is provided in accordance with such methods as are best suited to meet plant and operating requirements of the Telephone Company.

(a) Where service is furnished by the use of direct facilities, any class of service, other than service for Pay Telephone Lines, available in the foreign zone is provided.

(b) Where service is furnished by the use of indirect facilities, only individual line and branch exchange trunks are provided.

(2) The rates and charges, applicable to foreign zone exchange lines and trunks are the rates and charges for the class of service furnished. However, when service is furnished from a contiguous zone having over 300,000 main terminals, the combination of rates and charges for mileage, message rate, directory assistance and Service Charges shall be no less than the rates and charges for a like service provided in a normal zone.

(3) The rates and charges for all other items of service and equipment are the rates and charges applicable in the area within which the customer's network interface is located.

(4) The long distance and local message charges and the extent of local service applicable, are the same as apply to other exchange services provided from the same foreign zone.

b. (Cont'd)

(5) The rates specified for foreign zone mileage for a Series 2000, type 2006B, Channel in this Company's Channel Services Tariff, Section 3, contemplate service over only those lines located in the same building with the foreign zone main service.

c. Foreign Central Office Service is exchange service furnished from a central office other than the central office designated by the Telephone Company to serve a particular customer by the use of Series 2000, type 2006C, Channels.

(1) Foreign Central Office Service is provided pursuant to a specific request from a customer to receive service from such a foreign central office. In the absence of such a specific request, no service shall be considered to be provided from a foreign central office regardless of arrangement of facilities, the central office designation or the assignment of telephone number by the Telephone Company.

(2) Foreign Central Office Service is not in accord with the general plan of furnishing telephone service. The General Regulations Tariff, Provision and Ownership of Telephone Numbers, governs the determination of a customer's central office.

(3) Foreign Central Office Service is provided in connection with business individual lines, branch exchange trunks and Pay Telephone Lines or with residence individual lines and branch exchange trunks.

(4) Channel charges for Foreign Central Office Service apply in addition to all other charges for exchange service.

(5) The rates specified for foreign central office mileage for a Series 2000, type 2006C, Channel in this Company's Channel Services Tariff, Section 3, contemplate service over only those lines located in the same building with the foreign central office main service.

4. (Cont'd)

- d. Extension of an exchange service line is furnished to provide an additional connection of an exchange line at a different building/property than the first connection of the line by the use of a Series 2000, type 2011, Channel.
- (1) Extension service is not furnished in connection with Pay Telephone Lines.
- (2) Extensions of exchange service lines must be so located as to restrict their use to those entitled to use the customer's service, except where required to provide for the answering of calls at such times as the customer is not available at the main station connection. In such cases, when extension service is provided for answering of calls, the service is furnished only with the understanding that outward calls are not to be placed there from and ordinarily only on condition that separate exchange service is also furnished on the same premises/property.
- (3) Intercommunication is not contemplated between the connection of an exchange service line.
- e. An answering connection is an additional connection of a patron's Local Exchange Service, which may be connected in equipment of a Telephone Answering Bureau as specified in 7.b. following by the use of a Series 2000, type 2045, Channel.
- f. A concentrator connection is a connection of a patrons Local Exchange Service, which may be connected in equipment of a Telephone Answering Bureau as specified in 6.b. following by the use of a Series 2000, type 2041, Channel.
- g. A concentrator-identifier trunk is a Channel Service provided by the Telephone Company to extend a patron's Local Exchange Service from a concentrator located on the Telephone Company's premises to an identifier located at the Answering Bureau's Rate Demarcation Point, by use of a Series 2000, type 2043, Channel.
- h. When an Dedicated BRI Service-PRI Service or an entire High Capacity Digital Hand-off Service is provisioned to obtain Foreign Exchange, Foreign Central Office or Foreign Zone Service, month-to-month channel mileage rates apply for 1.544 mbps High Capacity Digital Service, as specified in the Channel Services Tariff.

This arrangement only applies when physical transport is required and all 24 channels of a High Capacity Digital Hand-off Service are provisioned on a Foreign Exchange, Foreign Zone or Foreign Central Office basis.

The end-to-end service must be within the same LATA, and must utilize Local Exchange Service provided from the normal serving Central Office.

5. Message Rate or Measured Rate Service with Flat Rate Service at the Same Customer Location

A combination of either message rate or measured rate service with flat rate service will not be furnished to the same business customer at the same location where the local service areas of the two services are identical, except as otherwise specified in the Telephone Company's applicable tariffs. This regulation, however, will not be interpreted to prevent the provision of both types of service where it is established that the one type of service is not to be used to supplement the use of the other type. Residence customers may have a combination of either message rate or measured rate service with flat rate service provided to the same customer or household on the same premises.

6. Service for:

a. Hotels and Hospitals

- (1) PBX trunks and Centrex lines or SEATs provided to hotels and hospitals may be provided for guest and patient use.
- (2) Flat rate PBX trunks and Centrex lines or SEATs are not provided at hotels, hospitals or other locations of a like nature, where the service is desired for use of those other than the management.
- (3) Service for hotels is primarily furnished to hotels, including motels, which, in the opinion of the Telephone Company, cater principally to transients but, may also be furnished to clubs and marinas, which offer accommodations and services similar to a hotel for guests and members.
- (4) All charges for the service including charges for any messages shall be billed to the hotel or hospital which shall be responsible for any prorating and billing of the charges to the guests and patients.
- (5) The hotel or hospital is responsible for all charges for telephone messages, telegrams, cablegrams and radiograms sent-paid from or received-collect at station lines or Centrex lines or SEATs of the hotel or hospital service, whether sent-paid or received-collect by the hotel or hospital for its own account or by or for others.

a. Hotels and Hospitals (Cont'd)

- (6) Station lines and Centrex lines and SEATs may be located in stores, shops and other businesses on the same premises/property which are not operated by the customer to provide for intercommunication-only with other lines connected to the system. The lines will not be provided unless a class of Local Exchange Service is furnished at each such place of business.
- (7) Hotel branch exchange or Centrex Service may be extended to condominium units of a condominium complex as station lines or Centrex lines or SEATs if the following conditions exist:
  - (a) The condominium unit owner has entered into a legal agreement with the owner or operator of the hotel allowing the latter to rent such condominium unit on a regular basis to the transient public while furnishing hotel branch exchange or Centrex Service.
  - (b) When a condominium unit owner occupies their condominium periodically and such unit is not available for rental to the transient public during any consecutive 30-day period, such condominium unit shall not be eligible for hotel branch exchange or Centrex Service during such periods unless the owner or operator of the hotel arranges for the outgoing portion of the service to be restricted from the telecommunications network. Unrestricted service can be restored when the unit is again available for rental.

b. Telephone Answering Bureaus

- (1) The answering bureau must subscribe to business Local Exchange Service, other than service for Pay Telephone Lines, for its own use. The telephone number of such service may be included in an alternate number listing contracted for by the patron, or in a regular additional listing in the patron's name contracted for by the answering bureau.
- (2) Service for Telephone Answering Bureaus may be provided either by direct connections or by answering connections. A direct connection may consist of an individual line, Toll Free Service access line, branch exchange station line or a Centrex line or SEAT. An answering connection is furnished only in connection with PBX trunks, individual lines, Toll Free Service access lines and Centrex lines.

b. Telephone Answering Bureaus (Cont'd)

- (3) Service for Telephone answering Bureaus will not be provided in connection with Pay Telephone Lines.
- (4) A patron's channels may be connected in the answering facilities of a telephone answering bureau at rates specified in this Company's Channel Services Tariff.
- (5) Concentrator connections, direct connections, and answering connections must be authorized by and billed to the patron.
- (6) Direct connections may not be used for outward calls by the answering bureau, except as specified for Joint User Service in Section 6, when contracted for by the patron. Answering connections may not be used for outward calls by the answering bureau.

7. Measured Rate Services

- a. Measured Rate Services provide for calling to stations within the local service area with each call charged for on a time-of-day, distance called and length-of message basis.
- b. Measured Rate Services are offered only in the exchanges and zones specified in Section 2 following.
- c. Rates for messages between two points are based on the airline mileage between rate centers, except when the two points are located within the same exchange or zone. Airline mileages between rate centers are determined as specified in this Company's Long Distance Services Tariff for Long Distance Message Telecommunications Service.
- d. For the purpose of determining charges the following applies.
  - (1) The rate for each message will be on a per-minute basis, with fractional minutes computed.

7. Measured Rate Services (Cont'd)

d. For the purpose of determining charges the following applies. (Cont'd)

(2) Chargeable time for all calls begins when connection is established between the calling line and the called line, branch exchange or Centrex system and ends when the calling line "hangs-up" thereby releasing the network connection. If the called line "hangs-up" but the calling line does not, chargeable time ends when the network connection is released either by automatic timing equipment in the telecommunications network or by the Telephone Company operator.

The Day, Evening, Night and Weekend rates apply to that portion of the message occurring within the rate periods stated below. The charges are determined separately for each rate period and the results are totaled.

Day, Evening, Night and Weekend rates apply as follows.

Discounts for the Evening, Night and Weekend reduced rate periods stated in the Rate Schedule are expressed as a percent reduction of the charge calculated at the Day rates of initial minute and additional minutes. They are applied to that portion of the message occurring within the rate discount periods stated in the table.

For all classes of service the discount is applied only to the sum of the initial minute and additional minute charges. The discount is computed separately for charges in each rate period and the results are then totaled.

\* Rates Applicable on Certain Holidays

On New Year's Day (January 1), Independence Day (July 4), Labor Day (the first Monday in September), Thanksgiving Day (the fourth Thursday in November), and Christmas Day (December 25), the holiday rate applicable is the Evening Rate, unless a lower rate would normally apply.

A. GENERAL

The regulations and rates contained herein are applicable to various local exchange telephone services furnished within each exchange or zone as specified in B.3. following.

B. REGULATIONS

1. Service for Customer-provided Shared Tenant Service and service for Pay Telephone Lines is provided as specified in Sections 3, respectively, of this Tariff.

C. RATES

1. Application of Rates

- a. Charges for monthly usage options apply in addition to the charges for dial tone lines.
- b. Business Rates
  - (1) Dial tone lines are available with either basic message rate service, basic measured rate service, or an unlimited monthly usage option, except as otherwise specified in B.3. preceding and 2. following.  
  
Basic message rate and measured rate services provide for charging on a per-call basis on calls to the local service area with no usage allowance included in the monthly rates. Charges per call are as specified in 3.a. following.
  - (2) The unlimited monthly usage option provides for unlimited local calling per month on a flat rate basis to dial tone lines in the local service area.
  - (3) Charges for calls to extended calling areas are as specified in the Extended Area Calling Tariff.

c. Residence Rates

- (1) Dial tone lines are available only in conjunction with a monthly usage option except for individual lines and PBX trunks.  
  
Individual lines and PBX trunks without monthly usage options are Local Exchange Services offered on a basic message rate or basic measured rate per-call basis. Charges per call are as specified in 3.a. or 3.c. following, as appropriate. Individual lines without a monthly usage option are economy service.
- (2) Monthly usage options provide for local calling on a monthly basis to dial tone lines in the local service area as follows:  
  
Unlimited Usage - No limit on the number of local calls per month for a flat rate.

Limited Usage

- A limited amount (Allowance) of message rate or measured rate calling as appropriate. For all calling over the allowance, additional rates per call apply.

Exchange Flat/Measured Rate

- No limit on the number of local calls for a flat rate to the exchange or zone on which the dial tone line is rated, and basic measured rate service on calls to all other exchanges and zones in the local service area.

- (3) Charges for calls to extended calling areas are as specified in the Extended Area Calling Tariff.

d. Determination of Rate Classes

- (1) Each exchange or zone is assigned to three rate classes for the application of exchange service rates according to the combined total of the number of dial tone lines in its local service area and extended calling area.

These rate classes are arranged in a rate schedule as shown in C.2. following.

- (2) The combined total number of dial tone lines in the local service area and extended calling area are computed as follows:

For Flat/Measured Rate Services and Message/Measured Rate Services, the dial tone lines in the local service area of each exchange and zone are multiplied by the appropriate distance factors. The dial tone lines in the extended calling area are then added to the dial tone lines as determined preceding for the local service area.

For Measured Rate Services, the dial tone lines in the local service area and the extended calling area of each exchange and zone are totaled.

For message rate hotel and hospital PBX trunks and service for Pay Telephone Lines, the dial tone lines in the local service area and the extended calling area of each exchange and zone are each multiplied by their appropriate distance factors and then totaled.

- (3) Distance factors are based on airline miles between the rate center of an exchange or zone and the rate center of each of the exchanges or zones in the local service area and extended calling area as indicated following:

- (4) When the Telephone Company proposes to change an exchange or zone from one rate class to another because of an increase or decrease in the combined total number of dial tone lines, notice of the reclassification of said exchange or zone to the proper rate class shall be given by filing revised tariffs with the State Corporation Commission in accordance with the rules and regulations of the State Corporation Commission and the laws of the Commonwealth of Virginia. Such revised tariffs will be filed only when an exchange or zone has exceeded or fallen below its rate class limitation by 5% or when an additional exchange or zone is added to the local service area, extended calling area and the new combined total number of dial tone lines exceeds the upper limit of the rate class.

VIRGINIA UNIVERSAL SERVICE PLAN

A. GENERAL

The Virginia Universal Service Plan (VUSP) is an offering designed to help qualified customers pay for their Local Exchange Service. Such qualified customers are charged a reduced rate for their local telephone service through the Lifeline Assistance Program (Lifeline).

B. REGULATIONS

1. Lifeline is available to qualified customers and is provided via a residence dial tone individual line. Only one lifeline credit is allowed per household.
2. Lifeline is Local Exchange Service and, as such, is subject to the regulations governing Local Exchange Service in this tariff. The rates specified herein for Lifeline Service apply in lieu of the rates for Local Exchange Service, except as may otherwise be specified following.
3. Lifeline Assistance is available to all residential customers who are currently participating in, or who have one or more dependents, and/or a member of the customer's household who currently participate in one of the following Federal or State Assistance Programs:

  - c. Medicaid
  - d. Federal Public Housing Assistance or Section 8
  - e. Veterans Pension
  - f. Survivor Pension

Lifeline Assistance is also available to residential customers when the household income of the named subscriber to the local telecommunications service is at or below 135% of the Federal Poverty Guidelines.

4. A Lifeline customer may subscribe to VUSP Toll Restriction Service at no charge. VUSP Toll Restriction Service is a service available to Virginia Universal Service Plan customers only. It allows the completion of local calls, calls to the operator for the completion of collect and third number billed calls, calls to 911 and to other N11 service codes, calls to 800/888 service telephone numbers, and local directory assistance calls. VUSP Toll Restriction Service prohibits interstate and intrastate toll calls, 700/900 calls, audiotex calls, collect and third party calls billed to the VUSP customer's line, busy line verification and interrupt services, interstate and intrastate long distance directory assistance calls, as well as Service Request.

\* VUSP customers who selected Call Restriction Service prior to May 1, 1998 may continue to subscribe to Call Restriction Service at no charge.

A. GENERAL

Extended Local Service (ELS) is a service, which adds one or more exchanges to the local service area of an exchange. Regulations and rates specified for ELS apply in addition to all other applicable regulations and rates specified in other tariffs of the Telephone Company.

ELS is provided only in response to a ballot of customers in the affected exchanges in which the majority vote in favor of the expanded service and the additional rate that will be incurred. The service is provided on the basis of two-way local calling between the exchanges.

B. REGULATIONS

HOME-BUSINESS SERVICE (Effective 12/20/04 - LA-3\*\*)

A. GENERAL\*\*

Home-Business Service is classified as a dual-purpose service and is intended to satisfy the communication requirements of customers who engage in business activities located in their homes. The service utilizes one individual dial tone line with two telephone numbers, and includes one residence directory listing and one business directory listing. The telephone numbers are answered in accordance with a distinctive ringing sequence.

B. REGULATIONS

1. Explanation of Terms

Home-Business Service Line

A Home-Business Service line consists of a dial tone line. Included with that line is one residence or primary telephone number, one business or dependent telephone number with distinctive ringing and a Home-Business Service Package. Unless specifically prohibited, other options available with residence service may be added to the line.

Home-Business Service Package

A Home-Business Service Package is one of nine local calling packages that provide a specific call allowance to be used only in conjunction with Home Business Service. Additional options may be added to the Home-Business Service arrangement, but are not considered part of the Home-Business Service Package selected.

2. Home-Business Service is not permitted to supplant Business Service arrangements located in a business establishment. Only one such arrangement is permitted to the same customer on the same premises.
3. Home-Business Service usage will be provided as message or measured rate service only. This service may not be provided in combination with flat rate service to the same customer on the same premises.
4. Home-Business Service is not provided on a foreign central office, foreign zone, or foreign exchange service basis if dedicated interoffice facilities are required to provide such service.
5. The Residence Service Variety Package and Distinctive Ring is not available with this service.
6. Residence rates will apply for Custom Calling Service features used with a Home-Business Service arrangement.

PAY TELEPHONE LINES (PTL)

A. GENERAL

Pay Telephone Lines (PTL) are individual dial tone line Local Exchange services for use by pay phone service providers to connect coin, coinless or combination coin/coinless pay telephones to the Telephone Company's network.

B. REGULATIONS

1. Four types of PTL are available: Network Controlled Coin Line (NCCL), Network Controlled Non-Coin Line (NCNL), Network Controlled Inmate Line (NCIL), and Customer-provided Coin and Credit Card Operated Telephones (COCOTS).

2. Explanations of Terms

Network Controlled Coin Line (NCCL)

Network Controlled Coin Line (NCCL) is a dial tone line, message or measured rate, Local Exchange service for use with coin-operated pay telephones.

The NCCL is equipped with network coin control capability which includes coin collect and return features, call rating capabilities and unique operator services which allow an end user to signal the operator during a call.

Network Controlled Non-Coin Line (NCNL)

Network Controlled Non-Coin Line (NCNL) is a dial tone line Local Exchange service for use with non-coin pay telephones, including card reader or credit card telephones. This line prevents the completion of chargeable direct-dialed local or chargeable direct-dialed toll calls without operator intervention.

Network Controlled Inmate Line (NCIL)

The Network Controlled Inmate Line (NCIL) is a dial tone line Local Exchange service for use with coinless and coin-operated telephones provided on the premises of city, county, state or federal prisons where institutionally authorized telephone programs warrant the service.

NCIL is provided for the purpose of originating: collect messages from coinless telephones and collect and local sent-paid messages from coin-operated telephones to numbers in the Telephone Company's North American Dialing Plan.

PAY TELEPHONE LINES (PTL)

B. REGULATIONS (Cont'd)

Network Controlled Inmate Line (NCIL) (Cont'd)

Calls to Telephone Company numbers such as repair service, directory assistance, live operator (0-), Toll Free numbers, 10XXX or 101XXXX, and public emergency service numbers such as 911 will be blocked from all Network Controlled Inmate Lines.

The following are standard blocking/screening features of the NCIL service:

- (1) Toll Billing Exception - is an inward screening that disallows the billing of collect or third number calls to the line.
- (2) Originating Line Number Toll Screening - provides special screening codes to the operator identifying any outward call screening on the line.
- (3) 700/900 blocking - prevents an exchange user from accessing 700 and 900 service telephone numbers.

Customer-provided Coin and Credit Card Operated Telephone Service (COCOTS)

Customer-provided Coin and Credit Card Operated Telephone Service (COCOTS) is a dial tone line, message or measured rated, Local Exchange service designed for use with station controlled pay telephones.

Call Screening, when used in connection with COCOTS, is an optional arrangement whereby outgoing calls, which are routed to a Telephone Company operator, will be processed only on a bill-to-third number, or collect call basis, as instructed by the calling party.

3. NCCL and NCNL pay telephone exchange lines may be provisioned as Two-way or One-way, Outgoing Only exchange lines.
4. NCCL and NCNL pay telephone exchange lines prevent the completion of incoming collect or third number calls, when such calls originate within the continental United States and when such calls are processed through the billing verification database. Outgoing operator-handled calls are restricted to collect, and third number only.
5. Directory Listings are not available with One-way, Outgoing Only NCCL or One-way, Outgoing Only NCNL pay telephone exchange lines.
6. Directory listings are available with NCCL Two-way, NCNL Two-way, and COCOTS pay telephone lines subject to the regulations applicable to listings for individual line business service.

\* NCCL will be billed on an unlimited flat rate basis until message and measured rate exchange lines are technically feasible for coin-operated telephones. At that time, all NCCL lines equipped with flat rate service will convert to a message or measured rate exchange line.

7. NCCL, NCNL, and COCOTS exchange lines may be provided with 700/900 Call Restriction as an optional feature, subject to the regulations and rates specified in the General Services Tariff.
8. Line Side Answer Supervision may be provided on NCNL and COCOTS exchange lines. This is an optional feature that detects and provides signaling to activate billing mechanisms upon connection of a call and deactivate billing mechanisms when the call is terminated.
9. Pay telephones connected to a PTL exchange line must be registered in compliance with Part 68 of the FCC's Code of Regulations.
10. NCCL, NCNL, and COCOTS subscribers are subject to the same Directory Assistance rates applicable to business service specified in the General Services Tariff.
11. Exchange users of NCCL, NCNL, and COCOTS must be permitted access at no charge to Universal Emergency Number 911 Services, the Telephone Company's operator, Toll Free Service numbers and Switched Access Service Feature Group B without charge.
12. Pay telephones connected to a PTL exchange line must be arranged to permit the completion of long distance calls and calls within the local service area where the service is located. Pay telephones connected to NCCL exchange lines must be arranged to return deposited coins on incompleting outgoing calls.
13. Nonpublished and Nonlisted Telephone Service described in the General Services Tariff will be provided at no charge upon the PTL subscriber's request.
14. Failure of the subscriber to comply with the provisions of this Tariff may result in the suspension or disconnection of the subscriber's service.
15. The PTL subscriber shall be responsible for the installation, operation and maintenance of any pay telephone used in connection with this service.
16. The PTL subscriber shall be responsible for payment of all charges, including applicable local, toll and FCC charges, associated with the provisioning of this service.

17. Long Distance Message Restriction, which is a detariffed service, is available on an optional basis for NCNL.

18. NCIL may be provisioned as a:)

(1) Coin One-way, Outgoing Mechanized Collect Access Line.\*

(2) Coinless One-way, Outgoing Mechanized Collect Only Access Line.

(3) Coinless Two-way access line.

C. RATES

1. The applicable local message charges and exchange areas for PTL exchange lines are as specified for business in Section 2 of this Tariff.

2. All sent-paid intraLATA toll calls will be handled by the Telephone Company and charged at the appropriate rate specified in the Long Distance Services Tariff, Section 2B for Operator Services or FCC No. 4 Tariff.

Any sent-paid intraLATA toll call that is not rated by the Telephone Company will be charged at the rate specified in the Long Distance Services Tariff, Section 2A for Business Two-point Service.

3. The Service Charges for PTL are specified in the General Services Tariff, Section 3.

4. The monthly NCCL dial tone line rate is the same in each rate class. The monthly NCNL dial tone rate is the same in each rate class.

5. The monthly dial tone line charges for Customer-provided Coin and Credit Card Operated Telephones (COCOTS) are specified in Section 2 of this Tariff.

\* Coin NCIL is provisioned the same as the coinless NCIL (One-way, Outgoing Only Mechanized Collect Only), except local sent-paid messages are permitted.

JOINT USER SERVICE

A. GENERAL

Joint User Service is a shared service arrangement, which allows the business telephone exchange service of a customer to be used, when designated by the customer, by individuals, firms or corporations not otherwise permitted use of the customer's business service by the Telephone Company's tariffs.

B. REGULATIONS

1. Joint User Service is offered on a business individual line, branch exchange trunk or Centrex line or SEAT, excluding dormitory Centrex lines, basis.
2. Joint User Service is only offered to customers whose telecommunications systems consist of 16 or less central office lines and 32 or less stations. Established Joint User Service on telecommunications systems with more than 16 central office lines or more than 32 stations as of December 18, 1986, will continue to be provided but on an LA-2 classification basis.
3. Application for Joint User Service, and for changes in service therewith, must be executed by the customer. The customer must be a user of the shared service arrangement and is responsible for payment of all charges incurred, regardless of whether such charges are associated with his usage, or that of any of his joint users, and such charges will be included on the customer's regular monthly bill.
4. Joint users of a customer's service must have the option of obtaining service directly from the Telephone Company. The joint users may subscribe to any other form of service regularly offered, provided such service is used in accordance with the regulation pertaining to Use of Customer's Service.
5. The total charges for telephone service rendered by the Telephone Company and allocated by the customer between the customer and each of the customer's joint users shall not exceed the charges of the Telephone Company to the customer as specified in the Telephone Company's applicable tariffs.
6. No separate call numbers or other distinctive designations are provided for the purpose of signaling the joint users.
7. Initial Contract Period and Termination of Service

Joint User Service is terminated and charges for Joint User Service are automatically discontinued upon termination of the customer's telephone service. Charges for Joint User Service may otherwise be discontinued at the request of the customer, provided that the joint user no longer utilizes any of the customer's service, and also that the terms of the initial contract period have been satisfied.

SERVICE FOR CUSTOMER-PROVIDED SHARED TENANT SERVICE

A. GENERAL

Service for Customer-provided Shared Tenant Service is a service arrangement, which allows the business Exchange Service and associated facilities of a customer to be reoffered by the customer to individuals, firms or corporations (patrons) not otherwise permitted use of the customer's business service by the Telephone Company's tariffs.

B. REGULATIONS

1. Service for Customer-provided Shared Tenant Service is offered on a business PBX trunk or Centrex Service basis, excluding dormitory Centrex lines, where the customer's system exceeds the capacity of 16 lines or 32 stations.
2. Service for Customer-provided Shared Tenant Service will only be provided on a message rate or measured rate basis. The entire shared tenant service system must be served by the same class of exchange service for both administrative and patron use.
3. Service for Customer-provided Shared Tenant Service is furnished to customers whose patrons occupy buildings or facilities that are within specifically identified contiguous property areas, even if the contiguous area is intersected by public thoroughfares or rights-of-way, and are either (a) under common ownership, which is either the same owners, common general partners, or common principal equity investors, or (b) within a common development which is either an office or commercial complex, a shopping center, an apartment or condominium or cooperative complex, an airport, a hotel or motel, a college or university, or a complex consisting of mixed users of the types heretofore described, but not to include residential subdivisions consisting of single-family detached dwellings.
4. Application for Service for Customer-provided Shared Tenant Service and for changes in services therewith, must be executed by the customer. The customer does not have to be a user of Service for Customer-provided Shared Tenant Service but is responsible for payment of all charges incurred, regardless of whether such charges are associated with his usage or that of any patron, and such charges will be included on the customer's monthly bill.
5. Shared tenant service providers shall furnish the Telephone Company a description of the contiguous property area prior to the establishment of service. The Telephone Company shall be notified of any changes in that area that occurs subsequent to the establishment of service.
6. Customers of Service for Customer-provided Shared Tenant Service may subscribe to residential and business additional directory listings on behalf of their residential and business patrons at the rates established for such additional directory listings in the General Services Tariff.

SERVICE FOR CUSTOMER-PROVIDED SHARED TENANT SERVICE

B. REGULATIONS (Cont'd)

7. Customers located within the shared tenant complex, as defined by the shared tenant service provider, shall have the option of obtaining service directly from the Telephone Company. Facilities to connect such customers to the Telephone Company shall be provided by the customer or by the shared tenant service provider or by the person controlling the inside or other wiring used by the shared tenant service provider. The cost of such facilities shall not be borne by the Telephone Company.
8. All rates and charges in connection with Service for Customer-provided Shared Tenant Service and all repairs and rearrangements on the customer's side of the network interface furnished by the Telephone Company including the shared tenant service provider's facilities, will be the responsibility of the person owning or controlling such facilities.

C. RATES

The rates, charges and local service areas for Service for Customer-provided Shared Tenant Service are as specified for Local Exchange Service, and for Centrex Services, in this tariff.

REMOTE CALL FORWARDING

A. GENERAL

Remote Call Forwarding is a telecommunications network service that utilizes a telephone number and electronic switching system central office facilities to automatically forward all incoming calls dialed to the Remote Call Forwarding telephone number to the terminating telephone number.

B. REGULATIONS

1. Remote Call Forwarding is offered subject to the availability of suitable facilities.
2. A Remote Call Forwarding arrangement includes the equipment necessary to forward one telephone call to a terminating telephone number.
3. Remote Call Forwarding calls may be terminated in Private Branch Exchange (PBX) trunks, Centrex Service, Toll Free Service and dial tone lines, and Pay Telephone Lines. A Centrex Service number may not be used as a Remote Call Forwarding originating number.
4. Remote Call Forwarding is provided on the condition that the customer subscribe to sufficient Remote Call Forwarding arrangements and terminating telephone numbers to adequately handle calls to the Remote Call Forwarding customer without interfering with or impairing any services offered by the Telephone Company. If in the opinion of the Telephone Company, additional Remote Call Forwarding arrangements or terminating telephone numbers are required, the customer will be responsible for subscribing to such additional Remote Call Forwarding arrangements or terminating telephone numbers. In the event the customer refuses to subscribe to such additional Remote Call Forwarding arrangements or terminating telephone numbers, such customer's Remote Call Forwarding service shall be subject to termination.
5. Where additional terminating telephone numbers are requested by the customer or required by the Telephone Company for association with the same Remote Call Forwarding number, such additional terminating telephone numbers must be of the same class and grade of service, and on the same premises, as the first terminating telephone number.
6. Remote Call Forwarding is not represented as suitable for satisfactory transmission of data.
7. The Custom Calling Service call forwarding feature is not offered for use with a Remote Call Forwarding terminating station.
8. The Telephone Company will not provide identification of the originating telephone number to the Remote Call Forwarding customer.

9. The classification of residence or business service for Remote Call forwarding arrangements is determined by the class of service of the terminating telephone number.
10. Charges for calls from the originating service to a Remote Call Forwarding telephone number are the responsibility of the originating service, unless such calls are accepted as collect at the terminating telephone number. Charges as specified in C. following for the forwarding of calls from the Remote Call Forwarding number to the terminating telephone number are the responsibility of the Remote Call Forwarding customer.
11. For any collect calls placed to the Remote Call Forwarding number, charges as specified in C. following for calls forwarded to the terminating telephone number apply regardless of whether or not such calls are accepted as collect at the terminating telephone number.

FOUR-WIRE SERVICE ARRANGEMENTS

A. GENERAL

Four-wire Service Arrangements permit switching that is designed to use four-wire connections to be connected to the Telephone Company's normally provided two-wire service facilities.

B. REGULATIONS

1. Four-wire Service Arrangements are provided only in connection with Foreign Exchange Service, Foreign Zone Service, and Foreign Central Office Service.
2. This offering contemplates the use of four-wire facilities between the local serving wire center and the switching equipment on the customer's premises, however, two-wire facilities may be used.
3. Transmission performance that meets the established standards of the Telephone Company will be obtained over facilities connected to a Four-wire Service Arrangement. If a customer requests improvement beyond this, additional equipment will be provided, where facility conditions permit, subject to additional rates and charges based on the costs incurred.

CENTREX SERVICES

A. GENERAL

Centrex Services are communications systems which include the ability for exchange access and intercommunication within the system, plus other features specified by the Telephone Company.

B. REGULATIONS

1. Centrex Services are offered by the Telephone Company at rates, charges and terms, as the Telephone Company shall determine.
2. The rates and charges for exchange access associated with Centrex Services are as specified in C. following.
3. Centrex lines and SEATs are classified as business service except as otherwise specified in 7. following.

Centrex Service furnished by central office type dial switching equipment is offered to new customers only from the Telephone Company's electronic switching system central offices subject to the availability of facilities and where, in the judgment of the Telephone Company, service may be provided by the use of service arrangements, equipment and facilities in quantities and types regularly furnished by the Telephone Company. Centrex Service may also be provided to new customers from previously equipped Telephone Company number 5 type crossbar central offices provided there is sufficient spare capacity.

Message or measured rate Centrex Service will be furnished only from exchanges where business individual line message or measured rate dial tone lines are offered. Flat rate Centrex Service may be furnished only from exchanges where business individual line dial tone lines with unlimited monthly usage options are offered. Centrex Service with Measured Rate Extended Area Calling will be furnished only as, and where, specified for Local Exchange Service in this tariff.

4. Centrex is offered only as a complete service. The exchange access and intercommunication portions of the service are not offered separately.
5. Where quantities of central office lines in excess of those considered adequate by the Telephone Company for Plan I service are requested by the customer, such additional facilities will be furnished at rates and charges based on the circumstances in each case.
6. Centrex I and II Services are provided on a message, measured or flat rate basis.

CENTREX SERVICES

B. REGULATIONS (Cont'd)

7. Dormitory Centrex Lines (LA-2)

- a. Centrex I and II Service is furnished to schools, colleges, and universities for management use in the administration of the school and for residential use on a flat rate basis by students, faculty members, or employees who reside in dormitories or other residential quarters owned, or leased, or under control of the school.
- b. Schools, colleges and universities may subscribe to dormitory Centrex lines under either Option A or Option B as follows:

(1) Option A

The school, college or university is responsible for payment of all charges. The school, college or university is also responsible for billing and collecting charges for telephone messages, charges for Directory Assistance Service, telegrams, cablegrams and radiograms sent-paid from or received-collect at dormitory Centrex lines.

(2) Option B

The Telephone Company is responsible for the billing and collecting of long distance charges, charges for Directory Assistance Service, telegrams, cablegrams and radiograms sent-paid from or received-collect at dormitory Centrex lines. The school, college or university is responsible for the payment of all other rates and charges applicable to the dormitory Centrex lines.

The school, college or university shall agree to either:

- (a) Assume responsibility for the payment of long distance charges billed to dormitory Centrex lines deemed by the Telephone Company to be uncollectible or
- (b) Render assistance to the Telephone Company in the prompt collection of such charges, in which event no responsibility for the uncollectible portion will be incurred by the school, college or university.

The Telephone Company reserves the right to change a dormitory Centrex line to a Centrex intercommunicating line in the event of nonpayment of charges billed to the dormitory Centrex line.

- c. All stations associated with a dormitory Centrex line will be located only within the same dormitory room or residential quarters.

B. REGULATIONS (Cont'd)

7. Dormitory Centrex Lines (LA-2) (Cont'd)

d. Dormitory Centrex lines that are located outside the wire center area for the primary location, charges apply as specified in the Channel Services Tariff for a Series 2000, type 2011, Channel.

e. Touch-tone is provided to dormitory Centrex lines only when the associated Centrex Service is equipped with touch-tone.

8. Centrex-50 Service is provided on a message or measured rate basis, and also on a flat rate basis for systems on Plan II.

9. Centrex Hotel Service is provided on a message rate basis. At the customer's request, installations may be furnished on a combination arrangement providing for administrative use on a flat rate basis in exchanges and zones where business flat rate service is offered, and guest's use on a message rate basis.

10. Suburban Centrex Service (LA-2)

a. Suburban Centrex Service is business service provided on a message rate basis. The charges for direct in and out local and long distance messages are those applicable to the zone from which the Suburban Centrex Service is provided except that the local service area and the charges for long distance messages placed to and from telephones bearing the central office designation 545, 602, 614, 692, 693, 695, 696, 697 and 746 and within the zone of the primary location, are those applicable to the Washington zone of the WMEA.

b. Foreign Zone Suburban Centrex Service

(1) Foreign Zone Suburban Centrex Service is Suburban Centrex Service for secondary locations furnished from one zone to a location in another zone of the WMEA.

(2) Foreign Zone Suburban Centrex Service is not in accord with the general plan of furnishing service and will be provided only where facilities are available.

(3) Foreign Zone Suburban Centrex Service Centrex lines or SEATs will be connected directly to Centrex dial switching equipment rated on the foreign zone. If the customer requests service from Centrex dial switching equipment other than that which is best suited to meet the plant and operating requirements of the Telephone Company, additional rates and charges will apply as specified for Foreign Central Office Service in this tariff.

B. REGULATIONS (Cont'd)

10. Suburban Centrex Service (LA-2) (Cont'd)

c. Foreign Exchange Suburban Centrex Service

- (1) Foreign Exchange Suburban Centrex Service is Suburban Centrex Service for secondary locations furnished in an exchange, which is contiguous to a Virginia zone of the WMEA.
- (2) Foreign Exchange Suburban Centrex Service is not in accord with the general plan of furnishing service and will be provided only where the foreign exchange facilities are available in the normal serving wire center of the normal exchange.

d. Special Location Suburban Centrex Service.

Special Location Suburban Centrex Service is Suburban Centrex Service provided by Telephone Company class five central office dial switching equipment which is an integral part of the telecommunications network of the Telephone Company and which, for security reasons, is located in secure space provided by and located on the customer's premises/property.

11. Centrex-99 Service Lines (LA-2)

Centrex-99 Service is provided on a message or measured rate basis, and also on a flat rate basis for systems on Plan II.

12. Centrex Business Pak (LA-2)

- a. Centrex Business Pak is offered under price schedules A and B as specified in C. following.
- b. Price schedules A and B are provided on a message or measured rate basis, and price schedule B is also provided on a flat rate basis where such service is offered.

13. Centrex Dedicated BRI Service-BRI

Access to the Public Data Network is provided in C. following, for all D Channel originating and terminating Centrex Dedicated BRI Service-BRI Connections up to 9.6 kbps.

14. The regulations, rates and charges for Centrex Custom Services are specified in the Miscellaneous Service Arrangements Tariff.

C. RATES

1. Application of Rates

- a. Centrex Services are offered under a Plan I (line basis) or a Plan II (SEAT basis) rate structure, except as otherwise specified following for Dormitory Centrex Lines and Centrex Business Pak Lines.
- b. New Centrex Services must subscribe to Plan II where the customers' serving central offices are equipped to provide the service. Existing Centrex Services under Plan I served by central offices equipped to provide Plan II, are subject to Limited Availability Classification LA-2. Plan I rates for proposed new Centrex Services offered to customers will be honored for up to 180 days from the bid date, or May 1, 1990, whichever occurs first.
- c. Customers with existing Plan I Centrex Services served by central offices capable of providing Plan II service, may change to a Plan II service by disconnecting their Plan I service and establishing a new Plan II Centrex Service.
- d. No mixing of Plan I and Plan II on the same Centrex Service will be permitted.
- e. Centrex Business Pak Lines price schedule A is subject to Limited Availability Classification LA-2. Price schedule A rates for proposed new services will be honored for up to 180 days from the bid date, or August 1, 1990, whichever occurs first.
- f. No mixing of Centrex Business Pak lines price schedules A and B will be permitted on the same Centrex Service.
- g. Customers with Centrex Business Pak lines price schedule A may convert to price schedule B.
- h. Local Exchange Service rates and charges apply to Centrex Service arrangements for all DEDICATED BRI SERVICE-BRI Access originating and terminating connections, up to 9.6 kbps, to the Public Data Network for each D channel Packet Switched Data Service provided.
- i. Order Processing, Line Connection and Line Change Charges will not apply to the initial installation of Centrex Full Feature Business Voice Systems, Centrex Full Feature Business Voice Systems 2100 or Communication system lines when installed under a term commitment.
